- **1.** Complete Chain of Custody (CoC) form, **including ordering physician and service type.** Please note this is a physician ordered test. We recommend patients meet with their physician prior to ordering.
- 2. Patient blood sample(s) submission types:


EDTA tube (available at most institutions / phlebotomy services) Tube size may vary between manufacturers, lab will need 8 ml of whole blood or 2 tube of 4 ml. Tube provided with kit. The cap closure is lavender/purple in color and includes an EDTA (anticoagulant) solution inside.

- **3.** Clearly print the following information on the **blood collection tube and CoC**. Failure to include this information may result in a delay of sample processing:
 - 1. Patient's date of birth (MM/DD/YY or MM/DD/YYYY).
 - 2. Patient's full name.
 - 3. Barcode (if available) OR patient's medical record number.
 - 4. Collection date.
- **4.** All collection supplies should be used within the expiration date and stored according to the manufacturer's instructions:

1. Samples that require storage prior to shipment are recommended to be stored at 2-8°C, up to a maximum of 5 days.

2. Prepare patients for blood draw; collect blood into the collection tube using your institution's recommended procedure for standard venipuncture. **It is recommended to collect 8 mL of blood per tube or 2 tubes of 4 ml each.**

3. Follow your institution's recommended procedure for storage while waiting for transportation.

DOCUMENTATION AND SAMPLE SHIPMENT

- **1.** Securely package patient blood sample(s) following the guidelines below, ensuring to double wrap when possible:
 - 1. Add water to the Ice bag and cool in freezer before collecting sample.
 - 2. Place blood sample in a hard plastic tube holder container.
 - 3. Attach ice bag to the tube holder using a rubber band.
 - 4. Place the complete item as detailed above in biohazard bag.
 - 5. Seal everything in bubble wrapped bag.
 - 6. And finally place in FedEx biohazard Overpack
- 2. Completed CoC (above) and put in FedEx package.
- **3.** Use Return Shipping label if provided otherwise use your own shipping label, use address below.
- **4.** Verify the shipping label information and affix label to outside of package:

5. Write "EXEMPT HUMAN SPECIMEN" on package in clear bold print.

1.Drop package at FedEx shipping facility, or call FedEx directly to schedule a pickup at 1-800-463-3339

2. Packages should ship with an Ice Pack provided with kit.
